Terms and Conditions of Entry for the Melbourne Stars Promotion

First up

1. These terms and the Schedule form the Conditions of Entry for this Promotion and set out all of the information you need to know regarding this Promotion. Capitalised terms have the meaning given in the Schedule, unless otherwise stated. If there's any inconsistency between these terms and the Schedule, then what's in the Schedule is correct. By submitting your entry, you agree that these Conditions of Entry apply to your entry.
2. The promoter is Victorian Cricket Association (trading as Cricket Victoria) ABN 28 004 128 812 of CitiPower Centre – Junction Oval, Lakeside Drive, St Kilda VIC, 3182 (**'Promoter', 'we', 'us'**).
3. Victorian Cricket Association (trading as Cricket Victoria) is a Declared Organisation in Victoria and holds a Victorian Commission for Gambling and Liquor Regulation (the VCGLR) declaration number 42963 under Chapter 8 of the Gambling Regulation Act 2003.

Who can enter ... and who can't

4. The eligibility requirements for this Promotion are set out in the Entry Restrictions.
